FROM THE CEO

Dear Friend,

I am in my office, exhausted but exhilarated and inspired after spending Saturday at the Women's March on Washington. 500,000 people, crowded, tired, and hungry but unfailingly polite, respectful and kind. 500,000 people and not a single arrest, not a broken window or single act of aggression. It was a beautiful display of "girl power," complete with pink hats and signs and banners both amusing and heartbreaking. And while there was certainly anger at the threats we are facing, the more prevalent sentiments were determination and joy in knowing we were coming together with millions of women around the world. The power of being part of a global movement, from Antarctica to Alaska, on every continent, and in cities large and small, reminded us that the power of our democracy lies in "We the people" and when we stand up and make our voices heard, we are on the road to fulfilling the American dream of justice and opportunity for all.

At the rally before the march, we were given courage by six year old Sophie Cruz, an immigrant activist whose message of hope, tolerance and resiliency demanded that we act. We shared the pain of the mothers of Trayvon Martin, Eric Garner, Sandra Bland and far too many other mothers whose children are not alive to join the march. We heard from feminist icons like Gloria Steinem, members of congress including New York's own Kirsten Gillibrand, celebrities, public officials, and women representing native people, LGBTQ people, people of color, disabled people, environmental activists, Muslim women and people from every faith and background. And in our glorious diversity we were connected by the simple notion that "women's rights are human rights" and the knowledge that none of us are free unless we are all free. As we made our way home, we committed ourselves to making sure that this was not a day that becomes a fond memory but that it is instead the beginning of a new period of activism and

advocacy. We committed ourselves to speaking the truth about our lives, our communities, and public policies and actions that threaten our freedom.

Taking action in defense of freedom, justice and opportunity is not only the work of the women's movement, civil rights movement or immigration activists. It is the work of Community Action. It is the work we are called to by the Community Action promise. It is the work we commit to, to make America a better place to live. It is the work of the mothers and fathers of the Community Action movement who came together to make real the promise of equal opportunity for all. It is the work of each and every one of us, the way we honor those who came before us and the way we will make real the promises we make to our children and generations to come.

It is with gratitude and humility that I recommit myself to the cause of women's rights, human rights and equality for all. Fighting poverty and supporting low income people and communities is core to the struggle for equality and our national community action network has never been more important. Our collective voice can give us power and strength. We will surely face trying times in the years ahead but I am more convinced than ever that together, we will prevail, justice will prevail and the promise of America will be real for all.

FrameWorks Institute - Changing the Conversation on Social Issues. The mission of FrameWorks Institute is to advance the nonprofit sector's communications capacity by identifying, translating, and modeling relevant scholarly research to frame the public discourse on social problems. FrameWorks designs, conducts, and publishes multi-method, multi-disciplinary communications research to empirically identify the most effective ways of re-framing social and scientific topics. Recognizing that there is more than one way to tell a story, Strategic Frame Analysis taps into decades of research on how people think and communicate. Framing refers to the subtle selection of certain aspects of an issue in order to cue a specific response. As researchers have shown, the way an issue is framed explains who is responsible and suggests potential solutions conveyed by images, stereotypes, messengers, and metaphors.
